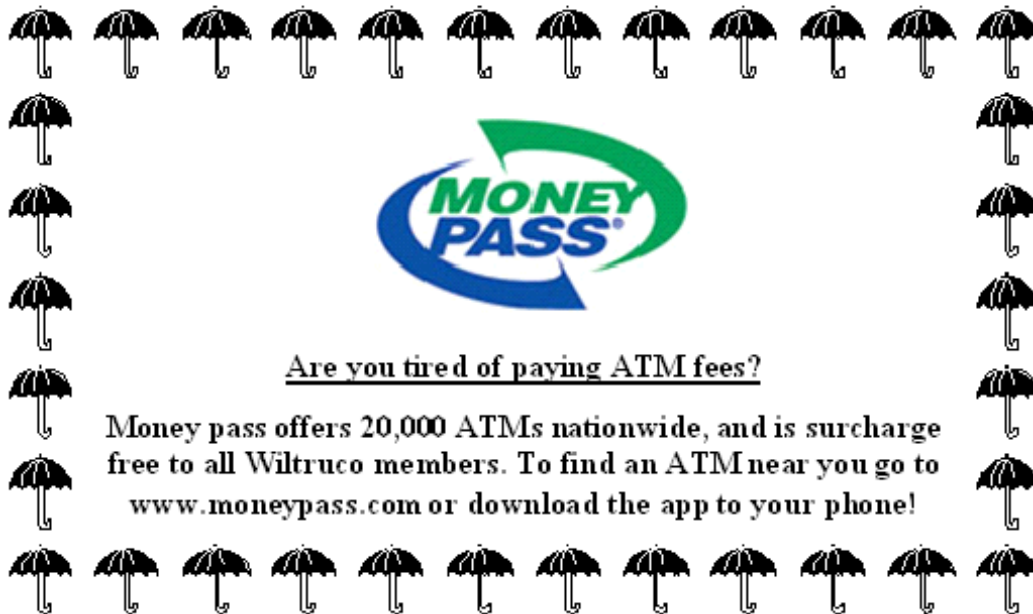

Regulation GG – Unlawful Internet Gambling Enforcement Act NOTICE

Unlawful Internet Gambling Enforcement Act of 2006 (UIGEA), 31 USC 5361-5366 prohibits gambling businesses from knowingly accepting payments in connection with restricted transactions: The participation of another person in a bet or wager that involves the use of the Internet and that is unlawful under any federal or state law.

You are hereby notified of the following:

You may not use your Wiltruco Bank account in connection with any business of playing, receiving or otherwise knowingly transmitting bets or wagers by any means which involves the use, at least in part, of the Internet, or for any other transaction which is prohibited by Federal Reserve GG and the law of Unlawful Internet Gambling Enforcement Act of 2006.

As a customer of Wiltruco FCU, these restricted transactions are prohibited from being processed through your account or banking relationship with us. We may block or close any account which we believe is in receipt of such transactions.
